### 3. 繪畫項目及規則:

#### 3.1 繪畫項目:

「繪畫組」- 水彩及粉彩畫、國畫(水墨)、非平面繪畫(剪貼畫)、油畫、木顏色、素描、水筆畫、和諧粉彩、塗鴉、廣告彩及塑膠彩。

「電繪組」- 電繪。

#### 3.2 「繪畫組」參賽者作品須以平面方式繪畫於尺寸不大於 55 x 55 cm 之畫紙上，可使用任何工具、顏料創作。繪畫組必須遞交實體作品。

「電繪組」- 參賽者作品之創作原始檔案必須妥善保存至賽事完結，即領取獎項及證書後。比賽期間本機構會隨時要求參賽者提交作品原始檔案，以作核實、評審等不同用途。未能在要求限期提交作品原始檔案，將取消參賽資格。

作品檔案需儲存為不大於 8 MB 的 JPG 或 PNG 檔案並在截止日前電郵至 [icaa.artexamhk@gmail.com](mailto:icaa.artexamhk@gmail.com)。



#### 3.3 每位參賽者只能提交一幅作品。

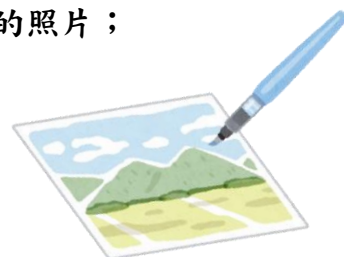

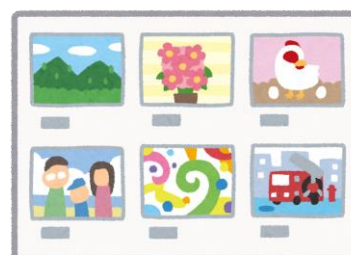

### 3. Painting Category and Rules:

- 3.1 "Painting Category" - Watercolor and Pastel Painting, Chinese Ink Painting, Clip Art, Oil Painting, Wood Color, Sketch, Water Brush Painting, Pastel Nagomi Art, Graffiti Painting, Poster Painting and Acrylic Paint.

***For participants in the "Painting Category," works must be painted in a flat manner on paper not exceeding 55 x 55 cm in size, using any tools and pigments for creation. Physical works must be submitted for the Painting Category.***

- 3.2 "Digital Drawing Category" - Digital Drawing.

***For the "Digital Drawing Category," the original files of the participants' works must be properly saved until the end of the competition, i.e., after receiving awards and certificates. During the competition, participants may be requested to submit the original files of their works at any time for verification, judging, and other purposes. Failure to submit the original files of the works within the specified deadline will result in disqualification. The artwork files should be saved as JPG or PNG files not exceeding 8 MB and emailed to icaa.artexamhk@gmail.com before the deadline.***

- 3.3 Each participant can only submit one piece of artwork.

- 3.4 The submitted artwork must be personally painted or digitally drawn by the participant, with guidance allowed from parents or teachers. If the artwork is not created by the participant, the entry will be disqualified, and the entry fee will not be refunded.

- 3.5 For the "Painting Category," please write the participant's name, competition category, and entry item on the back of the artwork. For the "Digital Drawing Category," please indicate

the participant's name, competition category, and entry item in the email when submitting



the artwork.

### 3.6 The following works will be disqualified:

- Photos obtained by violating others' rights;
- Photos containing controversial or inappropriate content such as pornography, nudity, obscenity, violence, and other inappropriate subjects;
- Photos involving deliberate harassment, disrespect, or destruction of natural ecosystems;
- Photos threatening the safety of individuals or animals;
- Artworks generated using any artificial intelligence software.

## 4. Registration:

### 4.1. Registration:

Participants must fill out the registration form on the institution's website.

### 4.2 Registration and Deadline:

## 5. Judging Criteria

Judging will be based on the overall artistic performance of the participants, as well as individual artistic judgment, considering the following aspects of the participants' performance:

- Structural Composition and Visual Tension
- Concept and Theme Expression
- Creativity and Originality
- Skill Application

## 6. Awards and Scoring

- 6.1 Winners of the Champion, First Runner-up, Second Runner-up, and Merit Awards will each receive a medal and a certificate. Once the medals and certificates are received, they will not be reissued if damaged or lost. In the event of a tie, equal awards will be given.
- 6.2 If the judges believe that a participant in a category does not meet the award-winning level, the judges have the right to adjust the award arrangements for that category.
- 6.3 Judges and the organizing committee have the right to make corresponding award arrangements and category adjustments based on the number of participants and their standards without prior notice.

## 7. Other Notes

The judges will make final decisions on all artistic matters. If any situation arises that cannot be resolved by any provision in these competition regulations or in all administrative and competition matters, the interpretation of the competition regulations by the Executive Committee of the institution will be the final decision.

## Personal Data Collection Statement

ICAA Limited is committed to protecting your privacy. The following information explains our practices and the collection and use of your personal data.

### Purposes of Collecting Personal Data

ICAA primarily uses the personal data of participants/organizations/responsible teachers/parents/legal guardians (referred to as guardians) for processing the Happy Moments Drawing Competition 2025 and any directly related purposes. ICAA may also use the provided personal data to contact participants/organizations/responsible teachers/parents/guardians during the event. Additionally, ICAA may publish the names, photos, competition details, and event proceedings of participants on webpages, newspapers, social media platforms, Facebook pages, and other media for promotional purposes.

Participants/organizations/responsible teachers/parents/guardians may voluntarily provide personal data to ICAA, enabling ICAA to register participants for the Happy Moments Drawing Competition 2025. Failure to provide the required personal data to ICAA may result in the inability to process the competition application.

### Transfer of Personal Data

To meet the aforementioned purposes, ICAA may transfer the personal data of participants/organizations/responsible teachers/parents/guardians to employees within the group, affiliated companies (including joint ventures), printing services and trophy suppliers hired by ICAA for the stated purposes, and the participant's affiliated school/group/organization. Apart from this, ICAA will not transfer the personal data of participants/organizations/responsible teachers/parents/guardians to third parties. If participants/organizations/responsible teachers/parents/guardians do not wish to receive such promotional information, they can email us.

#### Retention of Personal Data
